- iii) Have been an officer of the Customs and Central Excise Department who retired/resigned from the post of Commissioner of Customs/ Central Excise or above or retired /resigned as Member/Vice President / President of CESTAT /Settlement Commission and is enrolled / registered as Advocate in the High Court Provided that he has not been removed / dismissed or compulsorily retired from

service on account of disciplinary action against him and no disciplinary proceedings under service rules or pension rules is pending against him.
